YACHT CHARTER TERMS & CONDITIONS

PAYMENT TERMS
The contracting party agrees to pay a booking deposit of 50% of total invoice value at the time of booking and the remaining 50% balance 90 days prior to the booking. For bookings made within 90 days prior to a booking, the total booking fee will be due on confirmation of the booking. For 90 days below, the Client agrees to pay 100% of the total invoice to secure the booking. As soon as the payment is made, please scan and email us the bank slip to confirm the booking. We do not pencil book any booking without proof of payment.

CONFIRMATION
We will only accept a booking upon receipt of deposit and signed quotation. Until the booking deposit is paid and contract signed and returned, THE LUXE GUIDE LIMITED shall be free to offer the date in question to other parties.

CANCELLATION
If for any reason the Contracting Party cancels the booking more than 90 days prior the stay the booking, 20% of the amount paid will be forfeited, and the balance will be refunded. If for any reason the Contracting Party canceled the booking within 90 days prior to the booking, the whole amount paid will be forfeited and the Contracting Party shall be liable to pay the total price contracted for.

Cancellation at the instance of the Ship Captain – In the event of cancellation at the instance of the Ship Captain due to perils of the sea, extreme weather conditions, emergency repairs, and other analogous circumstances were, in the Ship Captain's discretion, the safety and

security of the Client and its guests will be imperiled, then yacht rental booking will be entirely refunded.

CHANGE OF THE BOOKING DATE

Once the booking is confirmed and signed any change of contracted booking date instigated by the contracting party up to 90 working days prior to the booking date, will incur an administration fee of 10% of the total contracted booking fee. The contracted booking date cannot be changed within 90 working days of the booking date without the full booking fee being incurred. Only one change of date is allowed, and within a year from the date of the change.

ADVANCE PROVISIONAL ALLOWANCE (APA)

For avoidance of doubt, the Rental Service Rate may include advance provisioning allowance ("APA") for fuel, food/catering, dockage fees, and other additional provisions agreed upon in advance by the parties. The rate of APA may be given in estimate. Any excess APA shall be returned to the Client. In the event of deficiency, the Client shall settle said amount immediately upon demand. The APA will be used by the captain to pay all the expenses that are not included in your invoice. The balance will be refunded to the clients after the completion of the experience.

REDUCTION IN NUMBERS

Should the Contracting Party reduce the number of Guests that he has contracted on behalf of, 7 days or more prior to the booking date, no cancellation charge will incur. If guest numbers reduce within 7 days of the booking date the Contracting Party shall be liable to pay 100% of the price attributable to each Guest.

POST BOOKING EXTRAS INVOICES

Invoices for extras shall be payable no later than 14 days following the date in which the invoice is dated.

THE LUXE GUIDE LIMITED'S AUTHORITY

The Contracting Party and each and every guest agree to abide and comply with any request or order made by or on THE LUXE GUIDE LIMITED's behalf on all grounds of safety and that THE LUXE GUIDE LIMITED's opinion is final and will be abided by howsoever expressed.

If in the opinion of THE LUXE GUIDE LIMITED, its Servants or Agents, the Contracting Party or Guest is behaving dangerously or is acting in a manner which would or may, in the opinion of THE LUXE GUIDE LIMITED, it's Servants or Agents, lead to a disruption of the services at the contracted booking, the Contracting Party or Guest will, at the request or order of THE LUXE GUIDE LIMITED, it's Servants or Agents leave the booking for the rest of the day contracted for, without THE LUXE GUIDE LIMITED, its Servants or Agents, encountering any liability.

LIABILITY FOR DAMAGE OR LOSS

The Client accepts liability to pay in full for any damage or loss to boats, vehicles, waterproof clothing, or other equipment supplied by THE LUXE GUIDE LIMITED, arising out of an act or omission of the Contracting Party or Guests. The Contracting Party and each Guest agree to limit any claims against THE LUXE GUIDE LIMITED to the risks and amounts insured against by THE LUXE GUIDE LIMITED and agree to observe the terms and conditions thereof. THE LUXE GUIDE LIMITED and its Servants or Agents accept no responsibility in respect of any damage whatsoever, to any property of the Contracting Party or Guests except where such damage is caused by the negligence of THE LUXE GUIDE LIMITED, its Servants or Agents.

DATA PROTECTION

THE LUXE GUIDE LIMITED complies in full with data protection and data security laws. All data held for your booking will remain your property. It will not be shared, copied, or retained after the booking. More specifically, delegate data will not be used for any other purpose than as instruction and in connection with your booking.

THIRD PARTY TERMS AND CONDITIONS

Where a service is booked for the client, and THE LUXE GUIDE LIMITED has booked this service as the client's agent, the client will be bound by the terms and conditions of this third party supplier.

COMMISSIONS

When acting as a booking agent, THE LUXE GUIDE LIMITED at times may receive a commission payment from the third party supplier or venue. This is not built into the fee charged to the client, and is a cost of sale for the supplier. THE LUXE GUIDE LIMITED does not have to disclose any specific details about these commissions, as these are part of a separate contract between THE LUXE GUIDE LIMITED and its partners. Fees are expressed in a quotation to the client. In the absence of a formal contract, an accepted quotation will constitute a formal agreement to pay the quoted fees.

DISPUTE RESOLUTION

Claims regarding non-delivery of services must be submitted by formal and recorded statement to the Director of THE LUXE GUIDE LIMITED immediately. Claims not reported in this way cannot be taken into consideration.

The Contracting Party and each and every Guest agree to save THE LUXE GUIDE LIMITED, it's Servants or Agents, harmless from and to indemnify THE LUXE GUIDE LIMITED, it's Servants or Agents against all actions, claims, costs, expenses and demands in respect of death or injury to the Contracting Party or Guests, arising out of or in connection with attendance at the contracted booking in circumstances where THE LUXE GUIDE LIMITED is not at fault.

THE LUXE GUIDE LIMITED, its Servants or Agents accept no responsibility for matters outside THE LUXE GUIDE LIMITED's control causing the contracted booking to be canceled or altered from the advertised or contracted program. The Contracting Party agrees that THE LUXE GUIDE LIMITED may change the booking contracted for without reduction in price in the instance of weather conditions rendering the original booking impractical or dangerous. THE LUXE GUIDE LIMITED may change the activity or product supplied if necessary but will endeavor to supply a similar activity or product. Where possible all changes will be discussed with the Contracting Party prior to the booking date.

It is hereby expressly agreed that each and every Servant or Agent of THE LUXE GUIDE LIMITED (including every Independent Contractor employed by THE LUXE GUIDE LIMITED) shall take the benefit of every exemption and limitation herein contained and every exemption from liability, defense and immunity of whatsoever nature applicable to THE LUXE GUIDE LIMITED or to which THE LUXE GUIDE LIMITED is entitled here under shall also be available and shall extend to protect every such Servant or Agent of THE LUXE GUIDE LIMITED. THE LUXE GUIDE LIMITED is or shall be deemed to be acting as Agent or Trustee on behalf of and for the benefit of all persons who are or might be its Servants or Agents from time to time (including Independent Contractors as aforesaid) and all such persons shall to this extent be or be deemed to be parties to the contract evidenced by this agreement. If any term of this Agreement is deemed to be void or unenforceable whether in whole or in part, the validity and enforceability of the remainder of this Agreement including any part of such term which is not held to be invalid shall not be prejudiced or affected and shall continue to apply subject to such amendment. Any additions or alterations of the terms and conditions of this agreement shall be null and void unless agreed upon in writing by the parties.
